State Personal Responsibility Education Program (PREP)

Oregon Health Authority

Oregon uses their PREP funding to provide evidence-based programming in school- and community-based settings in Jackson, Jefferson, Marion, and Multnomah counties. The programs focus on Latino youth living in areas with high teen pregnancy or birth rates.

Tribal PREP

Confederated Tribes of Grand Ronde \$316,782

Confederated Tribes of the Grand Ronde Community of Oregon serves approximately 150 7th and 8th grade youth annually, at Willamina Middle School. Although the program hasn't determined which curriculum to implement, *Native It's Your Game!* is being strongly considered.

Northwest Family Services (NWFS) will deliver the Deceptions project curriculum to youth ages 12-13 in schools in Multnomah and Clackamas Counties, OR. The Deceptions curriculum, delivered in six lessons, blends elements from an evidence-based sexual risk avoidance curriculum developed by NWFS and includes a supplement focusing on preventing sex trafficking. A caring adult will be available in

schools part-time to support students as part of the effort to incorporate a positive youth development aspect to the curriculum. Parent sessions and parent homework will be included to engage families.

**Teen Pregnancy Prevention (TPP) Program — Tier 1

Multnomah County Health Department - Portland, OR

Program models: *Get Real; Making Proud Choices!; Reducing the Risk*

Multnomah County Health Department Adolescents and Communities Together (ACT) project intends to reduce disparities in sexual health among young people and improve their ability to thrive, succeed educationally, maintain sexual and reproductive health, and be in healthy relationships. To achieve this goal, schools in participating districts will support the implementation of classroom-based curricula in middle schools and high school health classes in priority neighborhoods. Community partners will also reach youth and parents using culturally-relevant evidence-based programming along with other locally-identified youth development activities. MCHD plans to serve more than 12,000 young people annually.

Planned Parenthood of the Great Northwest - Seattle, WA

Program model: *Stronger Together*

The goal of the Stronger Together program is to assist organizations in implementing sexual health education to adolescents at high risk for unintended pregnancy; to increase organizational capacity to provide evidence-based sex education; and to reduce unintended teen pregnancy and improve health outcomes in areas of demonstrated need. In order to achieve this goal, Planned Parenthood of the Great Northwest and the Hawaiian Islands works with youth-serving community partner organizations to build capacity in three communities: **Medford, OR; Grants Pass, OR;** and Tacoma, WA. Training Specialists and Managers work directly with partner organization staff to provide training, skill building, and planning and program development assistance. Project staff provide observation and coaching to partner staff delivering evidence-based programs and work directly on sustainability efforts to assist partner organization in building long term capacity to engage in teen pregnancy prevention work.

The Northwest Coalition for Adolescent Health will deliver evidence-based teen pregnancy prevention programs to scale across four states, in seven communities with disparately high teen pregnancy rates. The communities are Caldwell, ID; **Salem, OR;** South Salt Lake City, Utah; Centralia, WA; East Tacoma, WA; and Mt. Vernon, WA. In each community there are three implementation settings ranging from faith-based institutions, to foster care youth programs, to high school settings and school based health centers.

**Teen Pregnancy Prevention (TPP) Program — Tier 2

Planned Parenthood of the Great Northwest (PPGNW) - Seattle, WA

Program models: *Linking Families and Teens (LiFT)*

\$1,000,000

PPGNW intends to reduce teen pregnancy rates, increase use of contraceptives, and delay initiation of sexual activity among rural, 9-12th grade youth by increasing parent-child connectedness, and increasing youth's self-efficacy, knowledge, and skill related to sexual health and pregnancy prevention in Alaska, Hawaii, Idaho, **Oregon**, Hawaii, Utah, and Washington. To achieve this goal, PPGNW implements LiFT, a program designed specifically for rural communities that brings 9-12th grade youth and their parenting adult together to share family values, strengthen family bonds, and talk about healthy relationships and sexual health.

Planned Parenthood of the Great Northwest - Seattle, WA

Program model: *IN•cluded: Inclusive Healthcare—Youth and Providers Empowered*

\$1,000,000

PPGNW intends to prevent teen pregnancy and sexual transmitted infections in the LGBTQ youth population. To achieve this goal, PPGNW implements the In•cluded program delivered in 14 communities in Alaska, Massachusetts, Minnesota, Montana, **Oregon**, Utah, and Washington through the PPGNW Teen Council Peer Education program. Each teen council group will deliver trainings to two different audiences: 1) IN•cluded for health care staff and providers, a three hour workshop delivered by peer teen educators in two 1.5 hour segments that include best practices for working with LGBTQ youth; and 2) IN•cluded for LGBTQ youth, a three hour interactive workshop delivered by teen peer educators to their peers who identify as gay, lesbian, bisexual, transgender, or queer/questioning. The workshop includes education related to sexual risk prevention and information about how to access sexual health services.

WestEd - Woburn, MA

WestEd and its partners Efficacy and the Oregon Youth Authority (OYA), are conducting a randomized controlled trial of an innovative teen pregnancy prevention program, Healthy U, for youthful male offenders. This study involves male teenagers (age 14-19) at high risk for involvement in risky sexual behavior, including teen pregnancy. The innovative, non-curricular, technology-based intervention, Healthy U, is self-directed, low-cost, user friendly, and offers great promise in reaching incarcerated youth. The purpose of this study is to test this intervention on a population of young men incarcerated at the OYA who will soon be released into the community. The intervention is tailored to this population by updating the design, videos, and examples to best reflect the youth in the study, and OYA staff are being trained to facilitate the self-guided intervention.

**Teen Pregnancy Prevention (TPP) Program — Tier 1
FY 2010 – FY 2014**

Planned Parenthood of the Great Northwest - Seattle, WA

Planned Parenthood of the Great Northwest is a partnership among six Planned Parenthood affiliates collaborating to administer the *Teen Outreach Program™* across five states. The partnership proposes to target high risk youth particularly of African American, Native American, Russian and Ukrainian races/ethnicities in 27 counties in Alaska, Idaho, Montana, **Oregon** and Washington. The program will serve 8,000 youth in grades 7-12 in school and in after-school programs. The project also includes an independently conducted rigorous evaluation. The outcomes of the program are to successfully reduce teen pregnancy rates and onset of sexual activity, increase contraception among sexually active youth, decrease academic failure and increase positive attitudes toward service and community engagement.

TITLE X FAMILY PLANNING SERVICES IN OREGON

- Title X–supported centers provided contraceptive care to 54,790 women in Oregon in 2014.⁵ These services helped women avoid 13,300 unintended pregnancies, which would have resulted in 6,500 births and 4,800 abortions.
- In the absence of publicly funded family-planning services, the number of unintended pregnancies and abortions in Oregon would be 83% higher.⁶
- By preventing sexually transmitted diseases, cervical cancer, and unplanned pregnancies, Title X-supported centers in Oregon saved \$64.3 million in public funds in 2010.
- From FY 2010 to FY 2017, the amount of federal funding Oregon received for Title X decreased by \$489,000, resulting in 27,153 fewer (38%) patients served.
- In 2017, 97 clinics in Oregon received support from Title X. They included health department clinics (63), school-based health centers (24), federally qualified health centers (6), and Planned Parenthood clinics (4).
