## **FEDERAL TEEN PREGNANCY PREVENTION GRANTS<sup>4</sup>**

### **State Personal Responsibility Education Program (PREP)**

Washington State Department of Health

\$1,007,171

The Department of Health is using its PREP funds to sub-contract with 10 local entities, who are providing evidence-based programming. The funds serve at-risk youth including African American and Latino youth, runaway and homeless youth, and youth in the foster care and juvenile justice systems.

### **Teen Pregnancy Prevention (TPP) Program — Tier 2**

The DOH Adolescent Health Program will work with state partners to adapt and test the All-Stars Curriculum, a character education program that emphasizes decision-making and goal-setting. Through the curriculum they aim to improve adolescent health, address sexual risk, and reduce teen pregnancy rates in Washington. The program will be implemented in-school to high school students ages 15-19 in Walla Walla, WA. The program serves all students but will be implemented in schools with large Latino populations. The DOH will use a quasi-experimental design to study the impact of the curriculum.

### **Teen Pregnancy Prevention (TPP) Program — Tier 1**

Planned Parenthood of the Great Northwest and the Hawaiian Islands - Seattle, WA

Program model: *Stronger Together*

\$750,000

The goal of the program is to assist organizations in implementing sexual health education to adolescents at high risk for unintended pregnancy; to increase organizational capacity to provide evidence-based sex education; and to reduce unintended teen pregnancy and improve health outcomes in areas of demonstrated need. To achieve this, the grantee works with youth-serving community partner organizations to build capacity in three communities: Medford, OR; Grants Pass, OR; and Tacoma, WA. Training Specialists and Managers work directly with partner organization staff to provide training, skill building, and planning and program development assistance. Project staff provide observation and coaching to partner staff delivering evidence-based programs and work directly on sustainability efforts to assist partner organizations in building long term capacity to engage in teen pregnancy prevention.

The Northwest Coalition for Adolescent Health (NWCAH) will deliver evidence-based teen pregnancy prevention programs to scale across four states, in seven communities with disparately high teen pregnancy rates. The communities are Caldwell, ID; Salem, OR; South Salt Lake City, Utah; Centralia, WA; East Tacoma, WA; and Mt. Vernon, WA. In each community there are three implementation settings ranging from faith-based institutions, to foster care youth programs, to high school settings and school based health centers.

Planned Parenthood of Greater Washington and North Idaho - Spokane, WA

Program models: *Project AIM, All4You!, Get Real, Making Proud Choices!, Seventeen Days, SHARP*

The goal of the Healthy Youth Collaborative is to reach a minimum of 2,000 youth across four communities in Washington by bringing evidence-based teen pregnancy prevention programs to scale. To achieve this goal, Planned Parenthood of Greater Washington and North Idaho implements Healthy Youth Collaborative programming within each community, in four different settings including middle and high schools, health centers, community-based organizations, and juvenile justice facilities.

### **FY 2015 – FY 2019**

Public Health - Seattle & King County - Seattle, WA

Program model: *FLASH*

\$1,000,000

Public Health--Seattle & King County is working to assist youth with preventing teen pregnancy, sexual violence, HIV, and other STDs, as well as improve family communication and increase youth knowledge of reproductive and sexual health. In order to achieve this goal, the grantee implements High School FLASH, a school-based sexual health education program in Georgia (Wilkinson, Twiggs, Hancock, Crawford, and Bibb Counties), as well as Ramsey County, Minnesota. The 15 lessons focus on building skills, positive attitudes, and positive peer norms to achieve the curriculum goals.

Planned Parenthood of the Great Northwest and the Hawaiian Islands (PPGNW) - Seattle, WA

Program models: *Linking Families and Teens (LiFT)*

PPGNW intends to reduce teen pregnancy rates, increase use of contraceptives, and delay initiation of sexual activity among rural, 9-12th grade youth by increasing parent-child connectedness, and increasing youth's self-efficacy, knowledge, and skill related to sexual health and pregnancy prevention in Alaska, Hawaii, Idaho, Oregon, Hawaii, Utah, and **Washington**. In order to achieve this goal, PPGNW implements LiFT, a program designed specifically for rural communities that brings 9-12 grade youth and their parenting adult together to share family values, strengthen family bonds, and talk about healthy relationships and sexual health.

Planned Parenthood of the Great Northwest (PPGNW) - Seattle, WA

Program model: *IN•cluded: Inclusive Healthcare—Youth and Providers Empowered*

\$1,000,000

PPGNW intends to prevent teen pregnancy and sexual transmitted infections in the LGBTQ youth population. In order to achieve this goal, PPGNW implements the In•cluded program delivered in 14 communities in Alaska, Massachusetts, Minnesota, Montana, Oregon, Utah, and **Washington** through the PPGNW Teen Council Peer Education program. Each teen council will deliver trainings to two different audiences: 1) IN•cluded for health care staff and providers, a three hour workshop delivered by peer teen educators in two 1.5 hour segments that include best practices for working with LGBTQ youth; and 2) IN•cluded for LGBTQ youth, a three hour interactive workshop delivered by teen peer

educators to their peers who identify as LGBTQ. The workshop includes education related to sexual risk prevention and information about how to access sexual health services.

**Teen Pregnancy Prevention (TPP) Program — Tier 1**

**FY 2010 – FY 2014**

Planned Parenthood of the Great Northwest - Seattle, WA

Program model: *Teen Outreach Program™*

\$4,000,000

PPGNW is a partnership among six Planned Parenthood affiliates collaborating to administer the *Teen Outreach Program™* across five states. The partnership proposes to target high risk youth particularly of African American, Native American, Russian and Ukrainian races/ethnicities in 27 counties in Alaska, Idaho, Montana, Oregon and Washington. The program will serve 8,000 youth in grades 7-12 (ages 12-17) in school and in after-school programs. The project also includes an independently conducted rigorous evaluation. The outcomes of the program are to successfully reduce teen pregnancy rates, decrease onset of sexual activity, increase contraception among sexually active youth, decrease academic failure and increase positive attitudes toward service and community engagement.

## TITLE X FAMILY PLANNING SERVICES IN WASHINGTON

- Title X–supported centers provided contraceptive care to 74,840 women in Washington in 2014.<sup>5</sup> These services helped women avoid 18,100 unintended pregnancies, which would have resulted in 8,800 births and 6,500 abortions.
- In the absence of publicly-funded family planning services, the number of unintended pregnancies and abortions in Washington would be 45% higher.<sup>6</sup>
- By preventing sexually transmitted diseases, cervical cancer, and unplanned pregnancies, Title X-supported centers in Washington saved \$178.6 million in public funds in 2010.
- From FY 2010 to FY 2017, the amount of federal funding Washington received for Title X increased by \$34,800. The number of patients decreased by 6,875 (7%) during this time.
- In 2017, 72 clinics in Washington received support from Title X. They included Planned Parenthood clinics (33), federally qualified health centers (21), health department clinics (8), school-based health centers (7), and family planning health centers (3).
