## FEDERAL TEEN PREGNANCY PREVENTION GRANTS<sup>4</sup>

## **State Personal Responsibility Education Program (PREP)**

Wyoming Department of Health \$250,000

The Wyoming Department of Health administers the state's PREP grant and it is managed collaboratively between the Communicable Disease and Adolescent Health programs. The Wyoming PREP grant program is implemented state wide both in school and community based settings. The program uses evidence-based curricula and targets adolescents between the ages of 12 and 17 years, with a special outreach focus on foster youth and youth with disabilities. School based programming is targeted at 9th grade.

## TITLE X FAMILY PLANNING SERVICES IN WYOMING

- Title X–supported centers provided contraceptive care to 7,950 women in Wyoming in 2014.<sup>5</sup> Those services helped women avoid 1,900 unintended pregnancies, which would have resulted in 900 births and 700 abortions.
- In the absence of publicly-funded family planning services, the number of unintended pregnancies and abortions in Wyoming would be 62% higher.<sup>6</sup>
- By preventing sexually transmitted diseases, cervical cancer, and unplanned pregnancies, Title X-supported centers in Wyoming saved \$24.1 million in public funds in 2010.
- From FY 2010 to FY 2017, the amount of federal funding Wyoming received for Title X decreased by \$32,784, resulting in 6,758 fewer (51%) patients served.
- In 2017, 19 clinics in Wyoming received support from Title X, including family planning health centers (11), health department clinics (7), and university-based health clinics (1).
