FP-2030-05	Increase the proportion of sexually active females aged 15 to 19 years who use a condom and hormonal or intrauterine contraception at last intercourse	National Survey of Family Growth (NSFG), CDC/NCHS	We strongly support this objective.
FP-2030-06	Increase the proportion of sexually active males aged 15 to 19 years who used a condom at last intercourse	National Survey of Family Growth (NSFG), CDC/NCHS	We strongly support this objective.
FP-2030-09	Increase the proportion of females in need of publicly supported contraceptive services and supplies who receive those services and supplies	National Survey of Family Growth (NSFG), CDC/NCHS; Guttmacher Institute Abortion Provider Census (APC), Guttmacher Institute	We strongly support this objective.
FP-2030-08	Increase the proportion of female adolescents who received formal instruction on abstinence, birth control methods, HIV/AIDS prevention, and sexually transmitted diseases before they were 18 years old	National Survey of Family Growth (NSFG), CDC/NCHS	Consider revising this objective to combine all youth regardless of gender (should remain gender neutral) to read “the proportion of adolescents”. Given diverse gender identities, we propose this is the best option to avoid a binary categorization.
FP-2030-10	Increase the proportion of females aged 20 to 44 years at risk of unintended pregnancy who use most effective or moderately effective methods of contraception	National Survey of Family Growth (NSFG), CDC/NCHS	We support this objective.

FP-2030-D01	Increase the proportion of publicly funded family planning clinics that offer the full range of reversible contraceptive methods onsite		Reword to say "full range of FDA-approved methods of contraception onsite" rather than "full range of reversible contraceptive methods onsite".
New proposed Core Objective for consideration	Increase the proportion of females in need of publicly supported reproductive health services and supplies who receive those services and supplies	National Survey of Family Growth (NSFG), CDC/NCHS; Guttmacher Institute Abortion Provider Census (APC), Guttmacher Institute	Consider adding complimentary Core Objective to FP-2030-09 about "reproductive health services". This would allow for assessment of services such as contraception, abortion, and other related reproductive health services.
New proposed Core Objective for consideration	Increase the proportion of sexually active adolescents aged 15 to 19 years who use any method of contraception at last sexual intercourse	National Survey of Family Growth (NSFG), CDC/NCHS.	This added objective would be similar to HP2020 FP-6 and would capture contraception use at most recent (or last) sexual intercourse.
New proposed Core Objective for consideration	Increase the proportion of females aged 15-44 years who received reproductive health services in the past 12 months	National Survey of Family Growth (NSFG), CDC/NCHS	This added objective would complement HP2020 objective FP7.1 and 7.2.
New proposed Core Objective for consideration	Increase proportion of adolescents who talked to a trusted adult (e.g., parent, guardian) before they were 18 years old about reproductive health topics such as abstinence, birth control, HIV/AIDS, or sexually transmitted diseases	National Survey of Family Growth (NSFG), CDC/NCHS	This measure would be comparable to FP-13.1-13.8 from HP2020 that addresses parent/guardian communication.
New proposed Core Objective for consideration	Increase the number of states with Medicaid Family Planning Expansions	Medicaid Family Planning Eligibility Expansions, Guttmacher Institute; Medicaid Income Eligibility Limits for Adults, Kaiser Family Foundation (KFF)	This measure is similar to FP-14 group from HP2020.

New proposed Core Objective for consideration	Increase the proportion of women delivering a live birth who discussed preconception health with a health care worker prior to pregnancy	Pregnancy Risk Assessment Monitoring System (PRAMS), CDC/NCCDPHP; California's Maternal and Infant Health Assessment (MIHA), California Department of Public Health (CDPH)	We feel strongly about the addition of this objective and it would match HP2020 MICH-16.1.
New proposed Developmental	Increase the proportion of women delivering a live birth who discussed post-delivery contraception	N/A	We strongly support the addition of this objective.
